
5. All issued shares are duly and validly issued in accordance with existing laws, rules and regulations and are likewise listed in the PSE, except for the shares referred to in item 8 below.

The Corporation issued 2,521,257 shares to the stockholders of CCPI in exchange for 500,000 shares in CCPI. The Corporation has applied for PSE listing of these 2,521,257 common treasury shares on June 30, 2023
